Thank you for the opportunity to comment on Docket No. 5022. Please see below:

The current pandemic we are experiencing is an unprecedented moment of crisis that none of us have experienced within our own lifetimes. This moment is greatly threatening and forcing grave risk on the health, well-being, and economic welfare of residents in Rhode Island. Importantly, these risks transcend our own political borders.

**This moment requires us to consider the important context within which we are living:**

1) There is so much that we don't know about the disease, its impacts, contagion, and viral behavior. This is forcing everyone to take our response one day at a time, as new information and data comes in. In short: *the virus is setting the timelines for us.* **Setting any deadline on utility relief for ratepayers at this time is arbitrary.**

2) This moment is bringing about an unprecedented exponential increase in the vulnerability of residents and small business owners. As more and more continue to lose their income, everyone at this time needs the precious little resources they have to survive and follow the public health guidance of experts and decision makers.

3) This moment is also exposing the shortcomings within our economic and social safeguards. With the amount of time forced upon us to end the pandemic, this is also a time to confront our shortcomings in public protections. This is the time to capture good data, while examining and reconsidering the policies that are needed to protect vulnerable ratepayers.

With the context above, I respectfully request the RI Public Utilities Commission to implement the following:

To whom it may concern:

I am writing the PUC to demand the following steps be implemented for the health and wellbeing of Rhode Islanders:

- **Permanent moratorium on shut offs for low-income households** Now is time for RI to lead on this issue and break the cycle of unfair shut offs on low-income families who have for too long have been forced to pay disproportionately higher utilities compared to more affluent households.
- **Emergency Utility Restoration for all low-income households without any down payment** The RI PUC passed a 10% deposit of back bill down for restoration which we support for affluent households but we demand that those who can't afford the 10% (those eligible for LIHEAP assistance) should not be punished with higher health risks based on their inability to pay a 10% deposit to profit the utility company. The RI PUC should mandate that all utilities restore electric, gas and water to low-income households. RI needs to follow the lead of water departments who have agreed to reconnect household currently without running water **without fees** to tackle the coronavirus pandemic.
- **Immediate implementation of the Percentage Income Payment Plan (PIPP)** Although with this order the RI PUC says that: *"Utilities are encouraged to offer flexible payment plans to all customers facing financial hardship, even short-term, during this time."* We know that utilities need clear instruction and enforcement. Therefore, we expect our public officials to be more specific and to order that utilities not charge LIHEAP eligible consumers more than 2% of their income for electric and not charge a total of more than 4% of their income for electric and heat or electric and gas.
  - We expect National Grid to voluntarily agree to these fairer percentages to avoid adding regressive costs to low-income households' energy burden. National Grid should stop jeopardizing the health of low-income households who continue to suffer from disproportionately high utility costs because of the lack of a Percentage Income Payment.
- Today's health crisis hits homes on fixed incomes extra hard, that is

why we need a tiered income-sensitive approach. It is time fight the forces of regulatory capture and for energy officials to prove their accountability and allegiance to the people of Rhode Island rather than to utility profiteers.

These actions need to be taken immediately for the health and wellbeing of the people in this state.

GREETINGS! With the ongoing COVID-19 Emergency, it was most fitting for your agency to allow suspending service terminations and collection activities of all regulated electric, natural gas, water and sewer utilities

Now is time for Rhode Island to lead on this issue and break the cycle of unfair shut offs on low-income families who have for too long have been forced to pay disproportionately higher utilities compared to more affluent households.

- For example, **Emergency Utility Restoration for all low-income households without any down payment** - The RI PUC passed a 10% deposit of back bill down for restoration which consumers support for affluent households but urge that those who can't afford the 10% (**those eligible for LIHEAP assistance**) should not be punished with higher health risks based on their inability to pay a 10% deposit to the utility company. The RI PUC should mandate that all utilities restore electric, gas and water to low-income households. RI needs to follow the lead of water departments who have agreed to reconnect household currently without running water without fees to tackle the coronavirus pandemic.

- Further, an **Immediate implementation of the Percentage Income Payment Plan (PIPP)** can go a long way. Although with this order the RI PUC says that: "*Utilities are encouraged to offer flexible payment plans to all customers facing financial hardship, even short-term, during this time.*" However, from past experiences, utilities need clear instruction and enforcement. Therefore, our public officials should be more specific and to order that utilities not charge LIHEAP eligible consumers more than 2% of their income for electric and not charge a total of more than 4% of their income for electric and heat or electric and gas.

- Additionally, National Grid should voluntarily agree to these fairer percentages to avoid adding regressive costs to low-income households' energy burden. National Grid should stop jeopardizing the health of low-income households who continue to suffer from disproportionately high utility costs because of the lack of a Percentage Income Payment.
- Today's health crisis hits homes on fixed incomes extra hard, that is why we need a tiered income-sensitive approach. It is time to fight the forces of regulatory capture and for energy officials to prove their accountability and allegiance to the people of Rhode Island rather than to escalate utility status.
