<u>PUC 3-1</u>

Request:

For the GCR Deferred Balances on page 7 of RMS/MJP 1, page 7, please explain the reason for the \$3.8 million under-recovery of fixed costs and the \$4.2 million under-recovery of variable costs.

Response:

The main driver for the under-recovery in both the fixed and variable deferred gas costs is the reduction in GCR revenue resulting from warmer than normal weather. The fixed deferred gas cost balance was under-recovered by \$3.8 million due to a \$2.4 million reduction in revenue and \$2.0 million increase in fixed gas costs, which was offset by a reduction of \$0.6 million associated with an update to November's beginning balance and monthly interest. The variable deferred gas cost balance was \$4.2 million under-recovered due to a \$3.5 million reduction in revenue and a \$0.7 million reduction in variable gas costs.
