With this filing, Verizon Rhode Island (“Verizon RI”) proposes to withdraw the following services from this tariff in wirecenters where Verizon continues to migrate its network to all fiber and retire its copper network. The RI PUC previously allowed the withdrawal of these same products in other wire centers where Verizon is migrating to an all fiber network.

- ISDN Basic Service
- ISDN Basic Service with Digital Centrex Service
- Feature Group A (FGA)
- Direct Inward Dialing for analog PBX trunks. Contracts with this service may not be extended nor renewed. (This does not impact ISDN PRI or Centrex DID subscribers).
