ORDER (First Enrollment)

The Renewable Energy Growth Program¹ is a tariff-based financing program for renewable distributed energy generation systems. The program is only available under The Narragansett Electric Company d/b/a National Grid (National Grid) tariffs.² The purpose of the program is to facilitate and encourage the installation and development of renewable distributed generation systems, reduce environmental impacts and carbon emissions, diversify generation sources, stimulate economic development, improve distribution system resilience and reliability, and reduce distribution system costs.³ Annually, the Public Utilities Commission (PUC) reviews and approves an enrollment schedule, technology targets, and ceiling prices against which commercial and large scale projects compete for participation in the Renewable Energy Growth Program. The program year runs from April 1st to the following March 31st. The 2021 Renewable Energy Growth Program targets and ceiling prices were approved on February 18 and March 29, 2021.⁴

R.I. Gen. Laws § 39-26.6-20(b) requires the PUC to review and issue Certificates of Eligibility for commercial scale and large-scale projects that have been chosen by National Grid

for participation in the Renewable Energy Growth Program. Following each enrollment, National Grid files an Enrollment Report. Pursuant to the R.I. Gen. Laws § 39-26.6-20(b), National Grid filed the First Enrollment Report for Program Year 2021 on June 24, 2021. National Grid reported that it had selected thirteen commercial, large-scale, and Community Remote Distributed Generation projects for PUC approval, for a total nameplate capacity of 26,071 kW. National Grid requested the PUC award Certificates of Eligibility for each.⁵ All projects had twenty-year terms and had bid in at or below their respective ceiling prices.

On July 27, 2021, the PUC reviewed and approved Certificates of Eligibility for each project, finding that in each instance, the projects were consistent with the applicable Renewable Energy Growth tariff enrollment rules. One project was composed of a combination rooftop and solar carport installations. The carport portion is allowed an additional ceiling price adder. The COE includes the following note: "Any change in the DC nameplate rating of a Solar Carport portion of a project as built must be provided to the Company prior to Authority to Interconnect, and adjustments to the Solar Carport Adder will be reflected in the final Certificate of Eligibility provided to the Customer." A copy of Attachment 1 to National Grid's Filing, "Rhode Island Public Utilities Commission (PUC)-Awarded Certificates," is marked as Appendix A, is attached hereto, and is incorporated into this order. However, the Company shall file with the Commission a final COE for the Ecogy Energy RI XXI LLC project once the final ceiling price with adder is determined.

Accordingly, it is hereby

1. Certificates of Eligibility are awarded to the projects listed in Appendix A to this Order.

2. The Narragansett Electric Company d/b/a National Grid shall file a final Certificate of Eligibility for the Ecogy Energy RI XXI LLC project once the final ceiling price with adder is determined.
