Hello Jared, attached is a draft of the route and detail sheets for the NK-Exeter Duct Bank - Phase II. Please confirm tie-in locations at all 3 termination points (102, 2, and the substation site). Also, please confirm the duct bank configuration, particularly if it changes as the duct bank moves out of the 102/2 intersection heading north on 102 and south on route 2. The detail shows 6-pipes, we can add/modify the detail as needed.

The manhole spacing is 700' or less from center to center and shows 3-way manholes at the termination points consistent with National Grid's past requirements. National Grid's input at this stage will be helpful so we have a clear path forward, and we may

also want to loop RIDOT into the conceptual route, if you would like our help coordinating that let me know.
