# <u>OER 2-1</u>

## Request:

In what stage(s) of project development and implementation does National Grid coordinate with the following entities (or leverage the databases and maps they maintain) when selecting projects?

- (a) RI Division of Statewide Planning
- (b) RI Department of Transportation
- (c) Municipal Planning Offices

### Response:

- (a) The Company does not coordinate directly with the Rhode Island Division of Statewide Planning. However, the RI Division of Statewide Planning may have projects that are managed through the Rhode Island Department of Transportation (DOT) with whom the Company does coordinate its work.
- (b) The Company engages with RI DOT during alternative development and evaluation as well as during detailed design for Company driven projects that involve RI DOT owned bridges. Additionally, the Company works very closely with RI DOT on all RI DOT public requirements projects that involve existing and/or future National Grid assets. The Company works with RI DOT as well as other departments of public works to coordinate construction.
- (c) During the needs assessment phase of Area Planning Studies, the Company consults with municipal planning offices when applicable. National Grid's Community and Customer Management team works directly with the cities and towns in the Company's service territory. For example, if there are known plans for significant future development in a certain area, the Company consults with the municipal planning offices and/or holds meeting(s) to discuss the details. This ensures that the Company's area study plans consider the municipality's long term plans. However, it is important to note, the Company places greater importance on municipal plans if specific customer requests exist. If needed, the Company works with the municipality to review their maps and/or records. Additionally, the Company consults with municipal planning officers during detailed design, permitting and/or construction as needed.
