July 2021

July 2nd , 2021

- Cycle 1 (Coventry former Cycle B) receives their last quarterly bill.
- Usage period April-May-June 15th
- Receive mailer that they will going onto monthly billing.
- Sept 2020 tariffs apply.

August 2021

August 2nd , 2021

- **Cycle 1 Coventry** (former Cycle B) receives their first monthly bill.
- Usage period June 15-July 15
- ***NEW*** August 2021 monthly customer charge tariff applied.

August 9th ,2021

- **Cycle 2 West Warwick** (former Cycle C) receives their last quarterly bill.
- Usage period May-June-July 22nd
- Receive mailer that they will going onto monthly billing.
- ***NEW*** August 2021 quarterly customer charge tariff applied.

September 2021

September 2nd , 2021

- **Cycle 1 Coventry** (former Cycle B) receives their second monthly bill
- Usage period July 15 - August 15
- ***NEW*** September 2021 monthly customer charge tariff applied.

September 9th ,2021

- **Cycle 2 West Warwick** (former Cycle C) receives their first monthly bill.
- Usage period July 22 to August 22
- ***NEW*** September 2021 monthly customer charge tariff applied.

September 16th ,2021

- **Cycle 3 Warwick/East Greenwich** (former Cycle A) receives their last quarterly bill.
- Usage period June-July-Aug 29
- Receive mailer that they will going onto monthly billing.
- ***NEW*** September 2021 quarterly customer charge tariff applied.

October 2021

October 1, 2021

- All fire services (public/private hydrants and fire lines) receives their last quarterly bill.
- Receive mailer that they will going onto monthly billing.
- September 2020 Tariff applied to last quarterly bill.

October 4th, 2021

- **Cycle 1 Coventry** (former Cycle B) receives their third monthly bill.
- Usage period August 15 - September 15
- *****NEW***** October 2021 monthly customer charge tariff applied.

October 11th, 2021

- **Cycle 2 West Warwick** (former Cycle C) receives their second monthly bill.
- Usage period August 22 -September 22
- *****NEW***** October 2021 monthly customer charge tariff applied.

October 18th, 2021

- **Cycle 3 Warwick/East Greenwich** (former Cycle A) receives their first monthly.
- Usage period Aug 29 -Sept 29
- *****NEW***** October 2021 monthly customer charge tariff applied.

November 2021

***** All Tariffs Effective October-1-2021 Applied *****

November 1st, 2021

- All fire services (public/private hydrants and fire lines) receive their first monthly bill

November 2nd, 2021

- **Cycle 1 Coventry** (former Cycle B) receives their fourth monthly bill.
- Usage period September 15 -October 15

November 9th, 2021

- **Cycle 2 West Warwick** (former Cycle C) receives their third monthly bill.
- Usage period September 22-October 22

November 16th, 2021

- **Cycle 3 Warwick/East Greenwich** (former Cycle A) receives their second monthly bill .
- Usage period Sept 29-October 29
