RE: Non-compliance with the Rhode Island Renewable Energy Standard for Compliance Year 2020 (Docket No. 5233)

Dear Attorney Vincent:

This letter is to inform you that your client, Liberty Counsel Power Holdings, LLC (Liberty) is out of compliance with Rhode Island's Renewable Energy Standard (RES) for Compliance Year 2020. As you may be aware, the Rhode Island Public Utilities Commission (PUC) is responsible for implementing the state's RES.¹

During the PUC's review of Liberty's RES Annual Compliance Filing for 2020 (Compliance Filing), the PUC noted a number of issues that Liberty must cure to come into compliance. On July 28, 2021, PUC staff contacted Liberty by email to identify three items that needed to be addressed and provide Liberty an opportunity to revise its Compliance Filing and come into compliance by August 13, 2021.² Of the three items noted in the email, two were mandatory: 1. addressing the discrepancy between the Asset ID in Liberty's compliance filing and The Narragansett Electric Company data,³ and 2. providing evidence that an Alternative Compliance Payment (ACP) of \$808,281.36 was paid to the RI Commerce Corporation.

On September 14, 2021, you responded that Liberty was not permitted to make ACPs due to its ongoing bankruptcy proceeding, but that you would be in contact with the PUC "as the process unfolds over the coming weeks," and attaching Judge Grossman's September 13, 2021 Order.⁴ The email did not address the Asset ID discrepancy Liberty was required to address.

On February 3, 2022, Judge Grossman issued an Order (the February 3, 2022 Order) granting the PUC's and the Rhode Island Division of Public Utilities and Carriers' (Division) Motion for Relief from the Automatic Stay.⁵

To date, Liberty is not in compliance with the PUC's regulations governing the 2020 RES. Pursuant to Section 2.10(A) of the PUC's Rules and Regulations Governing the Implementation of a Renewable Energy Standard (Rules), this letter hereby serves as a warning letter with a stated date of Compliance of February 10, 2022 at 4:00 p.m. If Liberty fails to provide further evidence that it is in compliance with the RES by this date, this matter will be placed on the PUC's February 11, 2022 Open Meeting agenda to find Liberty out of compliance with the RES for Compliance Year 2020.

Consistent with the February 3, 2022 Order, the PUC is not seeking at this time, and through this process, that Liberty remedy its noncompliance through ACPs to the RI Commerce **Corporation**. The PUC is merely following its regulations that afford Liberty clear notice and additional time to correct any error in staff's review of your 2020 Compliance Filing prior to its Open Meeting on February 11, 2022. Consistent with the February 3, 2022 Order, and pursuant to R.I. Gen Laws § 39-26-6(b) and § 39-1-27.1(c)(9), should the PUC find that Liberty failed to comply with the RES for Compliance Year 2020, the PUC may approve liquidation of Liberty's financial assurance held jointly by the PUC and Division.

Our apologies for the delayed response: we have been guite preoccupied with our Chapter 11 reorganization.

We have consulted our reorganization counsel, who has advised us that, unfortunately, we are not permitted to make any Alternative Compliance or similar payments. Doing so would negatively impact our bankruptcy estate, in contravention of the U.S. Bankruptcy Code.

That said, according to a recent agreement to sell substantially all our accounts, Liberty Power Holdings intends to wind up its entire business in Rhode Island by the end of this year. Please see the attached Order Approving Sale for more details. We will be in further contact with the Commission as this process unfolds over the coming weeks. In the meantime, please do not hesitate to contact me with any questions.

Dear Mr. Vincent,
During the Rhode Island Public Utility Commission's (RI PUC) review of Liberty Power's 2020 Annual Compliance Filing, one large and two smaller issues were identified that require attention and further action as follows:
1) During our review, it was noticed that no RECs were listed as having been retired in a Liberty Power Holdings RI settlement account, nor was any evidence of the required Alternative Compliance Payment (ACP) presented. Based on Narragansett Electric's Load Data, Liberty Power's total 2020 REC obligation = 11,292 (9,,880 New and 1,412 Existing). After applying 14 previously banked RECs in the 2020 Table 1 submittal (the full banked balance shown in Liberty's 2019 filing), this results in an adjusted 2020 REC obligation of 11,278 (9,866 New & 1,412 Existing) and a required Alternative Compliance Payment of \$808,281.36 (11,278 x \$71.58) . ← Evidence of the ACP must be submitted prior to the RI PUC's approval of Liberty's 2020 Annual Compliance Filing
Two other, less significant, items include:
2) Although an Excel version of Table 1 was provided, no PDF Version of Table 1 was submitted with the filing. Liberty should submit a PDF version of Table 1 to complete the RI PUC's records.
3) The asset ID noted for Liberty Power Holdings on Narragansett Electric's Load Data records is 14772, while the ID listed on Liberty's Table 1 was 50888. ← Resolution of this discrepancy is required.
Please provide documentation verifying the required ACP, a PDF version of Table 1, and an explanation or resolution of the discrepancy in the asset ID. Submit the requested information to RES.Filings@puc.ri.gov by August 13, 2021. Should you have further questions, send to RES.Filings@puc.ri.gov or contact me at 401-780-2107.

ORDER GRANTING THE RHODE ISLAND PUBLIC UTILITIES COMMISSION AND THE RHODE ISLAND DIVISION OF PUBLIC UTILITIES AND CARRIERS' MOTION FOR RELIEF FROM THE AUTOMATIC STAY

THIS CAUSE came before this Court on February 2, 2022 at 1:30 p.m. (the "Hearing") on *The Rhode Island Public Utilities Commission and The Rhode Island Division of Public Utilities and Carriers' Motion for Relief from Automatic Stay* (the "Motion") [ECF No. 530]. The Court, having considered the Motion and the presentation of the Movants, having been advised that the Debtors and the other parties in interest in attendance at the Hearing do not object to the entry of this Order, finding that the Motion was properly served, finding that no objections were filed to

the Motion, and otherwise being fully advised in the premises,

ORDERS as follows:

- 1. The Motion is **GRANTED** as set forth below.
- 2. Relief from the automatic stay is granted so that The Rhode Island Public Utilities Commission (the "Commission") and The Rhode Island Division of Public Utilities and Carriers (the "Division") may pursue all rights and remedies, and take any actions necessary, to commence, complete and obtain payment under that certain "License or Permit Bond," as defined in and attached to the Motion, without further order of the Court.
- 3. Neither the Commission nor the Division shall seek any remedies against the Debtors, other than their efforts to draw against or liquidate the Bond, as set forth in the Motion.
- 4. Nothing in this order shall constitute a finding or agreement by the Debtors or The Hanover Insurance Company as to any of the allegations contained in the Motion; including, but not limited to, allegations that the Debtors were obligated to comply with alternative compliance payments, or that the Debtors failed to make any such payments.
- 5. The provisions of Bankruptcy Rule 4001(a)(3) are hereby waived, such that this Order shall be effectively immediately upon entry.
