3. In Docket D-06-16 a Stipulation signed by all parties agreeing to Island Hi-Speed's petition for authorization to hold CPCN in dormancy.



STIPULATION AGREEING TO INTERSTATE NAVIGATION'S
MOTION FOR A ONE-YEAR AMENDMENT TO ITS FAST FERRY CPCN

The undersigned parties hereby stipulate and agree as follows:

1. Interstate Navigation Company's motion for a one-year amendment to its fast ferry Certificate of Public Convenience and Necessity (CPCN) filed on April 6, 2006, may be granted as filed.
2. Because Island Hi-Speed Ferry (IHSF) will not be operating from Point Judith to Block Island in 2006, the restrictions on Interstate's CPCN regarding the number, timing, and marketing of fast ferry runs between Point Judith to Old Harbor, Block Island may be eliminated. Also, in order to allow Interstate to fill the void created by IHSF's cessation of fast ferry service to Block Island from Point Judith, Interstate may be allowed to hold in abeyance the Newport to Block Island leg of its new fast ferry CPCN, in light of Interstate's commitment that conventional ferry service by Interstate between Newport and Block Island will continue as usual in the 2006 summer season.




STIPULATION AGREEING TO ISLAND HI-SPEED FERRY'S PETITION FOR
