The modified procedure has been followed and ~~the matter~~ has been assigned to the Division of Public Utilities and Carriers for disposition.

By petition filed with the Division of Public Utilities and Carriers on May 12, 1976, Newport Harbor Launch Service, Inc., and Oldport Marine Services, Inc., both of Newport, Rhode Island, seek authority for the transferee to purchase the operating right, equipment and real property of the transferor.

Newport Harbor Launch Services, Inc., has been operating as a common carrier, under Certificate No. W-1138, in the transportation of passengers and their baggage, by motor vessel, during the period between May 1st and November 1st, annually, within the confines of Newport Harbor. The water operations commenced on April 19, 1974, under the guidance of William T. Manning who subsequently became incorporated on April 15, 1974.

By the terms of the agreement entered into on or about May 15, 1976, Oldport Marine Services, Inc., would purchase the operating authority held by Newport Harbor Launch Service, Inc., also a launch, moorings, ground tackle and miscellaneous equipment for a purchase price of \$18,500, allocating \$4,800 to the operating rights, \$8500 to the transportation equipment, \$4,500 to the moorings, tackle and miscellaneous equipment. The balance of \$700 would be for the real property. As of December 13, 1975, the transferee's assets totaled \$25,130.56, of which \$4,649.57 represents cash on hand, total liabilities amounting to \$3,457.46, allowing for a net worth of \$21,673.10.

The transferee, in acquiring the water equipment owned and operated by the transferor, intends to conduct a service similar to that conducted by the transferor within the confines of Newport Harbor. By agreement, the transferee shall adopt the tariff filed with the Commission by the transferor and apply the rates and charges that were in force with the transferor.

CONCLUSIONS & FINDINGS

The Division of Public Utilities and Carriers concludes that the purchase by Oldport Marine Services, Inc., of the operating rights and property has been shown to be consistent with the public interest and that, accordingly the application should be granted. Therefore, it is


ORDERED: That the petition filed with the Public Utilities Commission, Division of Public Utilities and Carriers, on May 12, 1976, by Newport Harbor Launch Service, Inc. and Oldport Marine Service, Inc., seeking the approval of the Division for the latter to acquire the operating rights embraced in Certificate of Public Convenience and Necessity No. W-1138, presently held by the former should be and it is hereby granted,

IT IS FURTHER ORDERED, That the transferee shall arrange to publish and file an Adoption Notice with the Division of Public Utilities and Carriers and once filed, the transferee shall commence applying the rates formerly assessed by the transferor.

IT IS FURTHER ORDERED, That the transferee shall arrange to file with the Division of Public Utilities and Carriers a certified copy of either the License or Certificate, or both, issued by the United States Coast Guard, attesting to the ability of the operator of each boat as well as the seaworthiness of each boat authorized to board more than six (6) passengers.

IT IS FURTHER ORDERED, That upon compliance with the subject matter in the preceding ordering paragraphs, a certificate of public convenience and necessity will be issued.
