Now comes the Narragansett Bay Commission ("NBC"), and pursuant to Rule 31 of the Rules of Practice and Procedure for the Rhode Island Division of Public Utilities and Carriers ("Division"), hereby prays for relief from the June 29, 2015 Order in the above captioned Docket. In particular, NBC prays that the Hearing Officer amend page 3, footnote 4, to include the following language:

"The Commission confirmed its June 17, 2015 approval of NBC's rate filing in Docket 4562 at its June 29, 2015 Open Meeting."

Thus, the full footnote would read:

"Id., p.3 and Giebink Exhibit KG-1 and hearing transcript. The Commission confirmed its June 17, 2015 approval of NBC's rate filing in Docket 4562 at its June 29, 2015 Open Meeting."

NBC requires this amendment due to loan documentation requirements of the Rhode Island Clean Water Finance Agency. The Division's Advocacy Section has no objection to this Motion.
