3661 – Verizon Rhode Island: Verizon submitted a tariff filing proposal to increase the

day, evening and night per minute rates for Residence Regional Toll Calling (Message Telecommunications Service (MTS)) and Sensible Minute Optional Toll Calling Plan for effect March 19, 2005. After review, the Commission followed the Division's recommendation that the tariff be allowed to go into effect without suspension.

3662 – **Verizon Rhode Island:** Verizon submitted a tariff filing to RIPUC Tariff No. 18 to implement the FCC's new unbundled (UNE) rules regarding as set forth in the TRO Remand Order issued February 4, 2005. After review of the several objections and responses received, Chairman Germani moved to adopt on an interim basis, pursuant to RIGL 39-3-12, Verizon's proposed tariff filing. Adoption of the tariff filing is subject to further investigation to determine if the wording of the proposed tariff needs to be revised and if necessary, the CLECs would be entitled to any refund or compensation for any inappropriate rate or action by Verizon during this interim period.

3626 – Woonsocket Water Division: The Commission reviewed Woonsocket's Water compliance tariff filing submitted February 21, 2005. After review, Chairman Germani moved to approve the compliance filing. The motion was seconded by Commissioner Holbrook and unanimously passed. **Vote 2-0.**
