After review, the Commission followed the Division's recommendation that the tariff filings be allowed to go into effect without suspension.

- **3940 Verizon Rhode Island** Verizon filed on April 1, 2008, a tariff filing to implement rate increase to the various monthly residence local and regional packages for effect May 1, 2008. The Division filed a memo indicating that it has reviewed Verizon's tariff filing and finds that it conforms to the requirements of Verizon's Successor Alternative Regulation Plan and <u>Order No. 18550</u>. After review, Commissioner Holbrook moved to approve Verizon's tariff filing. Commissioner Bray seconded the motion and the motion unanimously passed. **Vote 3-0.**
- **3941 Verizon Rhode Island** Verizon filed on April 1, 2008, a tariff filing to implement changes to the Regional Essentials Bundle Discount and the Regional Essentials FiOS Bundle Discount for effect May 1, 2008. The Division has reviewed the filing and recommends that it be allowed to into effect without suspension. After review, the Commission followed the Division's recommendation.
- **3944 Verizon Rhode Island** Verizon filed on April 4, 2008, a tariff filing to limit the availability of the Business Link Rewards Plan to customers for effect May 4, 2008. The Division has reviewed the filing and recommends that it be allowed to into effect without suspension. After review, the Commission followed the Division's recommendation.
- **3927 Verizon Rhode Island** Verizon filed Amendment No. 1 to Interconnection Agreement executed between Verizon and MetroPCS Massachusetts, LLC. The Division

has reviewed the Amendment and recommends approval. After review, Commissioner Bray moved to approve the Amendment as filed. Commissioner Holbrook seconded the motion and the motion was unanimously passed. **Vote 3-0.**
