#### **Minutes of Open Meeting Held July 26, 2013**

**Attendees:** Chairperson Margaret Curran, Commissioner Mary Bray, Commissioner Paul Roberti, Cindy Wilson-Frias, Amy D'Alessandro, Alan Nault, Dilip Shah, Nicholas Ucci and Luly Massaro. Staff Patricia Lucarelli and Sharon Colby Camara were not present.

Chairperson Curran called the open meeting to order at 10:00 A.M. in the first-floor hearing room of the Public Utilities Commission. A quorum was present. Chairperson Curran turned over presiding duties to Commissioner Bray as it was Commissioner Bray's last open meeting.

**Minutes of Open Meeting held on July 11, 2013:** Chairperson Curran moved to approve the minutes. Commissioner Roberti seconded the motion and the motion was unanimously passed. **Vote 3-0.**

#### **Competitive Telecommunications Service Providers**

The following companies filed an application for authority to transact as telecommunications service supplier in RI. The Division reviewed the applications and recommended approval of:

- 4424 – Local Access LLC
- 4426 – i-wireless, LLC

After review, Chairperson Curran moved to approve the applications. Commissioner Roberti seconded the motion and the motion was unanimously passed. **Vote 3-0.**

After review, the Commission followed the Division's recommendation that the tariff filings be allowed to go into effect without suspension.

#### **Renewable Energy Resources Eligibility Applications for Generation Facilities**

The following companies submitted an application seeking certification or re-certification as an eligible renewable energy resources. Commission Consultant submitted

memorandum summarizing its review that the facility meets the requirements for eligibility as a Renewable Energy Resource and recommended approval of:

- 4409 – West Greenwich Solar, LLC’s application seeking certification for its West Greenwich Solar Generation Unit, a 2.158 MW solar energy Generation Unit located in West Greenwich, RI
- 4413 – Swanton Village Electric Department’s application seeking certification for its Highgate Falls Generation Unit, an 11.392 MW Small Hydro energy Generation Unit located in Highgate, VT
- 4415 – Village of Enosburg Falls’ application seeking certification for its Enosburg Hydro Generation Unit, an 0.975 MW Small Hydro energy Generation Unit located in Enosburg, VT
- 4416 – Barton Village, Inc. Electric Department’s application seeking certification for its Barton Hydro Generation Unit, an 1.4 MW Small Hydro energy Generation Unit located in Barton, VT
- 4395 – North Hartland, LLC’s application seeking certification for its North Hartland Bypass Flow Turbine Generation Unit, an 0.138 MW Small Hydro energy Generation Unit located in Hartland, VT
- 3814 – North Hartland, LLC request to re-certify renewable energy resources application to modify the percentage of New and Existing generation allocation of the North Hartland Hydroelectric Facility.

After review, Chairperson Curran moved to approve the applications for certification and the request for re-certification as submitted. Commissioner Roberti seconded the motion and the motion was unanimously passed. **Vote 3-0.**
