## Minutes of Open Meeting Held on May 31, 2019

An Open Meeting of the Public Utilities Commission was held on May 31, 2019 at 10:00 A.M. in Hearing Room A, 89 Jefferson Boulevard, Warwick, Rhode Island to discuss, deliberate and/or vote on the following dockets.

Present: Chairperson Margaret Curran, Commissioner Marion Gold, Commissioner Abigail Anthony, Todd Bianco and Luly Massaro.

- I. Chairperson Curran called the Open Meeting to order at 10:07 A.M. A quorum was present.
- II. The PUC reviewed the Renewable Energy Resource the eligibility applications submitted in the following dockets. After review, Chairperson Curran moved to grant conditional eligibility with the requirement that the applicants submit documentation verifying commercial operation date and assignment of NEPOOL GIS Id number. Commissioner Anthony seconded the motion and the motion was unanimously passed. **Vote 2-0.** 
  - a. **Docket No. 4940 NuGen Capital Management, LLC & NUGen Manager, LLC's** application for eligibility certification of the NuGen Solar, LLC generation unit, a 4.98 MW AC (6.016 MW DC) solar facility located in Bristol, Rhode Island, as a New Renewable Energy Resource.
  - b. **Docket No. 4941 GD Richmond Buttonwoods I, LLC's** application for eligibility certification of the GD Richmond Buttonwoods I, LLC generation unit, a 1.25 MW AC solar facility located in Richmond, Rhode Island, as a New Renewable Energy Resource.
  - c. **Docket No. 4945 GD SK Rose Hill, LLC's** application for eligibility certification of the GD SK Rose Hill, LLC generation unit, a 0.63 MW AC solar facility located in South Kingstown, Rhode Island, as a New Renewable Energy Resource.

Chairperson Curran moved to decertify the Quarry Energy Project's eligibility as a Rhode Island renewable energy resource facility. Commissioner Anthony seconded the motion and the motion was unanimously passed. **Vote 2-0.** 

- d. **Docket No. 3988 Quarry Energy Corporation's** request to decertify the Quarry Energy Project generation unit and remove from the Rhode Island list of eligible Renewable Energy Resource.
