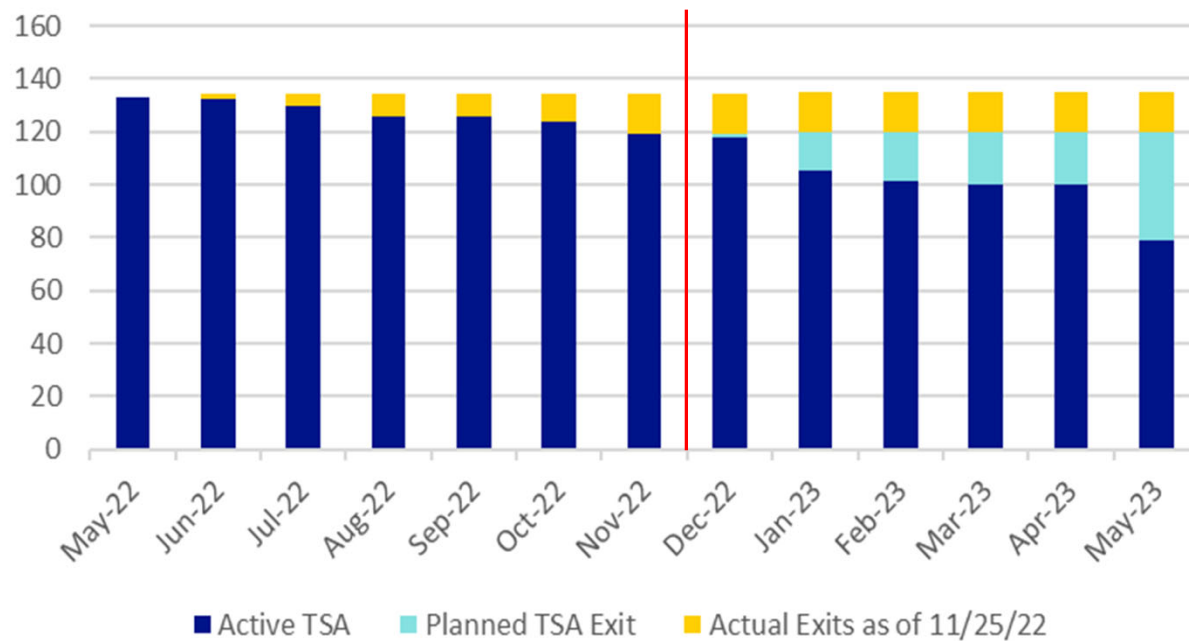

TSA Legal End Date Schedule


