## NOTICE OF TECHNICAL RECORD SESSION

These dockets relate to PUC's review of The Narragansett Electric d/b/a Rhode Island Gas Infrastructure, Safety and Reliability (ISR) Plan for fiscal years 2023 and 2024. R.I. Laws §39-1-27.7.1(d) requires the gas distribution company to file with the Commission an annual infrastructure, safety, and reliability annual plan for its anticipated capital spending forecasted for the applicable fiscal year. The law also allows a reconciliation of actual costs incurred against rate recovery. The PUC approved the Company's FY 2023 and 2024 ISR Plans.

At this Technical Session, the PUC will be asking clarifying questions regarding (i) the Company's ISR Annual Reconciliation filing submitted on August 1, 2023 relating to FY 2023 (April 1, 2022 – March 31, 2023), (ii) the Company's quarterly update in Docket No. 22-54-NG relating to its ongoing capital investments for the first quarter (April 1, 2023 – June 30, 2023) of fiscal year 2024 which update was filed on August 15, 2023, and (iii) the Company's budgeting and planning processes relating to its annual capital investment planning generally.
