- I. Call to Order
- II. **Docket No. 24-13-FR Jamestown & Newport Ferry Company** The Company submitted proposed tariff filing for the 2024 season commencing May 18, 2024. The Division of Public Utilities (Division) filed a Memorandum summarizing its review of the filing and recommending approval of the rates as filed. The Commission will review and vote on the Company's tariff filing.
- III. **Docket No. 24-14-EL Pascoag Utility District** Pascoag Utility District filed a rate application to implement new rates to take effect May 5, 2024. The utility seeks to increase revenue requirement of \$444,918, a 4.73% increase over the test year revenue. The Commission will suspend the proposed rates to conduct discovery and hearings on the rate application
- IV. **Docket No. 23-23-NG The Narragansett Electric Co. d/b/a Rhode Island Energy** This docket relates to Rhode Island Energy's Gas Cost Recovery Charge. The tariff requires the Company to calculate the seasonal BTU content based upon the prior six-month experience for the equivalent season, which the Company proposes that it take effect for the applicable May 1 and November 1 period. The Commission will review and rule on the Company's BTU Content Factor Filing for effect May 1, 2024.
- V. **Docket No. 4237 The Narragansett Electric Co. d/b/a Rhode Island Energy** In accordance with statutory mandate and Commission Orders, Rhode Island Energy filed its 2023 Contact Voltage Annual Report on January 12, 2024 and subsequently filed a revised report on January 31, 2024. The Division submitted a summary of its review of the Company's filing, comments and recommendations to adopt. The Commission will review the record and rule on the Company's compliance report.
- VI. **Docket No. 24-10-EL The Narragansett Electric Co. d/b/a Rhode Island Energy** In accordance with legislative changes and Commission's directives, Rhode Island Energy filed to amend the Company's Net Metering Tariff Provision for effect May 1, 2024. The Commission will suspend the tariff to conduct discovery and hearing on the Company's filing.

VII. Docket No. 23-44-REG - The Narragansett Electric Co. d/b/a Rhode Island Energy and Rhode Island Distributed Generation Board - This docket relates to the Commission's review of proposals by Rhode Island Energy and the Rhode Island Distributed Generation Board (DG Board) for the Renewable Energy Growth Program (RE Growth) Years 2024 through 2026. The proposals are submitted pursuant to R.I. Gen. Laws 39-26.6 et seq. Rhode Island Energy proposed modifications to the Company's RE Growth Program and Tariffs and Solicitation and Enrollment Process Rules. The DG Board recommended renewable energy growth classes, tariffs term lengths, capacity targets and ceiling prices and related ceiling price adjustment mechanism for RE Growth Program Years 2024 through 2026. The Commission will review the record and rule on the proposals submitted by Rhode Island and the DG Board.
