Re: Implementation of Basic Service Tier Rate Changes

Dear Mr. Martin:

Pursuant to the Division's Cable Rules, Chapter 11, CoxCom, Inc., d/b/a Cox Communications New England ("Cox") is providing an original and four (4) copies of this notice to the Division of proposed increases in its Limited Basic service tier rates, effective as of August 1, 2008. Cox also is providing for informational purposes only changes in its Expanded Basic service tier rates and changes in its Limited Basic rates in Service Areas 5 and 6 (all of which are unregulated). With regard to Service Area 6, the Federal Communications Commission recently found that Service Area 6 is subject to effective competition by virtue of Verizon's entry into Service Area 6 (CSR 7495-E, Memorandum Opinion and Order (April 10, 2008)). Cox also is notifying the Division of an increase in its DVR Service (Primary Only) rate.

On February 13, 2008, the Division approved Cox's Form 1240 Maximum Permitted Rates ("MPR") and Form 1205 Equipment and Installation rates, which covered communities in seven (7) Rhode Island Service Areas (Report and Order, Docket No. 2007-C-4 (Order 19204)). Cox did not increase its Limited Basic service tier rates in these service areas at that time, and has not increased its Limited Basic service tier rates within the twelve (12) month period preceding August 1, 2008.

The Limited Basic service tier increases subject to the MPR previously approved by the Division will be implemented in Service Areas 1, 2, 3, 4, 7 and 8. Enclosed with this letter are schedules showing (1) Cox's current Limited Basic service tier rates for these Service Areas, the MPRs, the proposed new Limited Basic service tier rates effective as of August 1, 2008, and the amount of the rate increase by service area (The public access charge is listed separately); and (2) changes in Expanded Basic service and DVR service (primary only) rates.



Cox requests that the Division incorporate by reference its Form 1240 filing approved by the Division in Report and Order, Docket No. 2007-C-4 (Order 19204 dated February 13, 2008).

A copy of the tariffs to be effective as of August 1, 2008, also is included with this filing. Cox will be hand delivering to the Division on June 20, 2008, sample letters to be sent to subscribers in specific communities, based upon the services received and the rate changes involved for these services.
