## NOTICE OF RULEMAKING AND PUBLIC HEARING

Pursuant to the provisions of R.I.G.L. §§39-1-15, 39-3-33, 39-14.1-2, 39-14.1-6, 39-14.1-8 and 42-35-3, the Division of Public Utilities and Carriers (hereinafter "Division") will conduct a public hearing on <u>April 30, 2014 at 10:00 AM</u> in Hearing Room A, located at 89 Jefferson Boulevard, Warwick, Rhode Island, for the purpose of considering a possible amendment to Division rules titled "Rules and Regulations Governing the Transportation of Passengers Via Public Motor Vehicles." These rules and regulations govern the transportation of passengers via public motor vehicles in Rhode Island.

On November 15, 2013, the Division granted a petition to re-examine the 40.00 minimum allowable charge as stipulated in Rule D(1). This rule making is limited to determining whether the prescribed minimum charge should be retained or amended.

Since Public Motor Vehicle companies, as common carriers under R.I.G.L. Title 39 Chapter 14.1, are utilities within the meaning of R.I.G.L §39-1-2(20), and therefore under R.I.G.L. § 42-35.1-3(c)(8), are not considered small businesses for the purposes of R.I.G.L. §§ 42-35-3 and, this rulemaking proceeding is exempt from the requirements of those sections regarding regulations affecting small businesses. Nevertheless, the Division does not believe that the proposed rules will have a significant adverse economic impact on any small business or on any city or town.
